Coastal Police Headquarters has been established and started functioning at Kochi. Public information officers, as prescribed under Section 5 of the Right to Information Act, 2005 has to be designated in the Coastal Police Headquarters, to deal with the applications/ appeals under the Right to Information Act, 2005. In pursuance of the proposal submitted as per the reference cited, the following officers are designated as the Asst. Public Information Officer, State Public Information Officer and Appellate authority in the Coastal Police Headquarters, with immediate effect.

Appellate authority	Addl. Director General of Police, Coastal Police HQrs, Kochi
State Public Information Officer	Asst. Inspector General of Police, Coastal Police HQrs, Kochi
Asst. Public Information Officer	Administrative Assistant, Coastal Police HQrs, Kochi

The Addl. Director General of Police, Coastal Police Headquarters, Kochi is directed to take immediate steps to display names of the newly designated Asst. Public Information Officer, State Public Information Officer and Appellate Authorities in conspicuous places for giving information to the public. Nominal roll of Asst. State Public Information Officers, State Public Information Officers, Appellate Authorities and their telephone numbers will be send to DGP SCRB immediately, for publishing the same in the official website of Kerala Police.
