The LA Cell will work 24 hours, all the communication received will be handled by LAI Cell, obtain answers from concerned Special Units/Sub Divisions/ Sections and forward same to the office concerned with in the stipulated time limit. LA Cell will keep separate registers for LA Questions and answers and day to day abstract is also to be furnished

III. The Inspector of police Telecommunication Unit Painavu will personally make it sure that the messages are quickly transmitted. The Motor Transport Officer, Idukki will make available the service of a Motor Vehicle with a Rider at DPO Idukki for the delivery
