All the LAI Messages/CoB Messages received from the Government or PHQ and other Superior Authorities should be entered

in a separate register serially numbered and handed over to the officer concerned at once. All the communication received after office hours should be received by Dy.Suptd of Police, SB Idukki who will pursue expeditious action on it in order to sending reply without delay and handover to Dy.Supt.of Police, DCRB Idukki who is in charge of LAI Cell. The cell is responsible for the prompt reply to the LA questions and to attend all the works in connection with the LAI Cell. In Holidays turn duty clerk will attend the LAI questions from 10 A.M to 5 P.M. In every working days One senior clerk or Clerk must be available in this office from 5 P.M to 6 P.M as turn duty for conducting LA related matters. Turn duty clerks can avail 1 compensation leave for each 3 days LA duty after the completion of LA Session with prior information.

III. The Inspector of police Telecommunication Unit Painavu will personally make it sure that the messages are quickly transmitted. The Motor Transport Officer, Idukki will make available the service of a Motor Vehicle with a Rider at DPO Idukki for the delivery of messages in LA matters and light vehicle with good condition to meet the urgent situation in connection with LA duties. D1 Section Clerk who is the custodian of LA Register, should maintain the register promptly with legible entries then and there. Smt. Bhanumathi Office Attendant DPO idukki shall assist D1 section till the end of the LA session. All subordinate officers will ensure the correctness and genuineness of the figures and LA answers furnished by them within the time limit and ensure to send a copy of the LA answer to D1 section while sending the reply. The officers concerned will be personally held responsible for furnishing false or incorrect answers to LA questions. Reply furnished earlier should be referred for avoiding different answers in the same questions.
