ORDER

As per the G.O read as 1st paper above Thrissur Police District has been bifurcated into Thrissur City Police District and Thrissur Rural Police District. The State Police Chief has now informed that the jurisdiction of Thrissur City Police District became very limited in area and highly disproportionate compared to that of Thrissur Rural Police District and the number of Police Stations in the two Police Districts were 14 and 27 respectively. Also exists a massive difference in the Crime statistics between Thrissur City and Thrissur Rural Police Districts and the workload in terms of the investigation and other police duties were also disproportionate.

State Police Chief has requested to restructure the jurisdiction of Thrissur City and Thrissur Rural Police Districts in a scientific manner, so as to ensure effective policing and better service delivery to the public at large. State Police Chief has furnished revised jurisdictional area for Thrissur City and Thrissur Rural Police Districts.

Government have examined the matter in detail and are pleased to accord sanction for restructuring jurisdiction of Thrissur City Police District and Thrissur Rural Police District as per the following tables A& B:
