Government had enhanced the existing rate of Fees/charges realized for services rendered by the Police Department including Forensic Science Laboratory as per Govt. order cited 1st & 2nd.

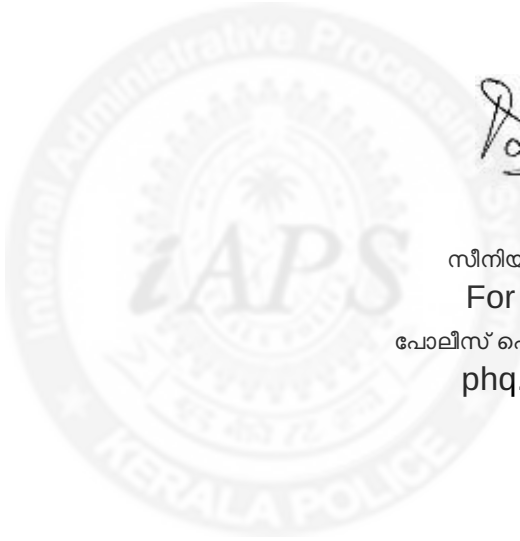
