The meeting took the following decisions regarding the conduct of Police Kalamela.

- The Police Kalamela will be conducted at two levels- District and State level for the following 24 items: Bharathanatyam, Mohiniyattam, Kathakali, Ottanthullal, Mimicry, Caricature, Poster Designing, Pencil Drawing, Digital Painting, Troll Creating, Oppana, Kathaprasangam, Mappilapattu, Mono Act, Indian Classical Music, Story Writing, Flute, Veena, Violin, Guitar, Essay Writing, Aksharaslokam, Margam Kali, Contemporary Light Music. The participants are grouped as Juniors (Children of Police Personnel/ Ministerial Staff) and Seniors (Police Personnel/~~Ministerial~~ *STAFF and their spouses*)
- District Level competitions have to be completed within **10.06.2019** and list of winning teams/ personnel may be forwarded in the name cover of AIG.
- For the above, the District comprises all the Police offices in the district including Battalions, Crime Branch Offices, Special Branch Offices, Special Units if any in the

District. The expenses for conducting District Kalamela can be met from "34-Other Charges" head of account @ Rs. 1 Lakh per District.

- An organising Committee under the Chairmanship of ADGP North Zone alongwith IGP, Kannur Range, DPCs of Kozhikkode City, Kozhikkode Rural, DCP of KKD City, SP, Traffic North, SPs of Crime Branch and Special Branch in KKD District is to be constituted immediately. Shr P.Vijayan IPS, IGP Admn is included as a nominee from Police HQrs in the coordination Committee. The Coordination Committee has to decide the dates for conducting the final events- two options- **from 14th June to 16th June** and **21st to 23rd June** -are suggested. Final events may be conducted as a three day programme- two full days starting on a Friday evening and ending on a Sunday afternoon.
- DPCs shall be the Chairperson of District Level Competitions. The programme is not like school Kalamela/ Yuvajanotsavam. No disputes of any kind regarding the conduct of the events will be entertained. The decisions of the judges will be final. Hence everybody should try to conduct it as a prestigious event.
- The State Level event shall be conducted in a suitable Auditorium in Kozhikkode District. The Coordination Committee will select a suitable Auditorium for the same. Total expenses for the conduct of the event should be limited within Rs. 50 Lakhs.

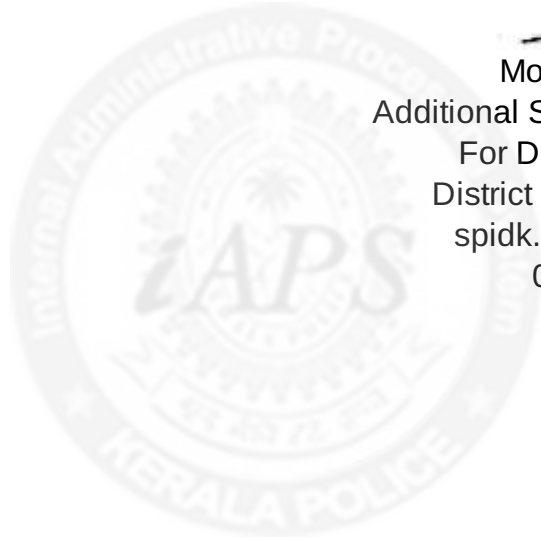
