The envelop containing tender should be prescribed "tenders for Supply of Smart Phone (40 Nos) for District Special Branch, Idukki with tender number and addressed to the District Police Chief, Idukki. The tenders will be opened at 11 am of 28.7.2018 in the presence of such tenderer or their authorized persons who may be present at that time.

2 The tenderer should enclose an agreement as prescribed in tender forms in stamp paper worth Rs.200/.
